100% to be paid by banktransfer the day of the performance!

Any resulting taxes (e.g. foreigner tax, VAT etc.) or social charges and visa, work permits expenses (if needed), Covid test expenses (if needed) will be organized and paid by promoter.

With regard to the travel restrictions in connection with the COVID-19 pandemic, the organizer undertakes to inform the agency about possible entry stops, necessary COVID tests, permitted audience size and any upcoming changes in this regard. The organizer is liable for any costs caused negligently by misinformation in this regard.

Hotelcharges (room and breakfast) will be paid by the promoter.

Hotelreservation will be arranged by promoter according to rooming list for:
2 single rooms with large, "queen- or kingsize" beds or double rooms for single use.
ONLY NON SMOKING ROOMS ACCEPTABLE.

Hotels of very good quality (FOUR (4) stars category and/or according to "rider" demands to be reserved only!
Hotels and must be approved by the agency and must have a restaurant and roomservice.
All rooms must provide free wireless internet connection.

3. Promoter will bear the costs of the technical specifications:
AS PER ENCLOSED " RIDER " = PART OF CONTRACT

4. Promoter is obliged to return CONCERT DETAILS by email to Saudades by 23.08.2022 at the latest.
The Details are stated in our Concert Details sheet (which the promoter receives together with the contract) and contain:

- complete time schedule, including: time of load in, time of soundcheck, time of doors open, time of show
- hotel informations, venue information.
- main contacts, including: promoter, urgency contact, tech contact, venue contact (name, email, cellphone)
- details of local transportation (airport/trainstation - hotel - venue - hotel - airport/trainstation)

5. Any kind of recording or broadcast is not permitted and requires a separate contract!
 Provided radio- or tv/video-recording was agreed upon, artist has to receive a disk of the recording immediately after performance - free of charge and for private, non commercial use only!
 A further disk - both free of charge - will have to be sent to Saudades Tournéen within one week after the performance.

6. Promoter is obliged to declare performance to the respective copy- or performance rights collection company incl. declaration of compositions performed during the concert.

7. Promoter will send all press cuttings relating to the performance directly to agent.

8. In case the concert will be connected or related to a political event, agency needs to be informed before signing contract in order to get permission from artist to perform. In case agency wasn't contacted artist may have the right to refuse performing! Agreed fee + hotelexpenses need to be paid by promoter in this case!

9. Promoter will provide free of charge 2 stage hands to help musicians / crew to set up and clean stage.

10. Promoter will provide free of charge for musicians and crew:

a) Beverages (coffee, juice, softdrinks, mineralwater, beer, red and white wine), as well as snacks, sandwiches, fruits etc. in sufficient quantity.
 Catering to be arranged for both soundcheck and concert!
 Please arrange for clean and guarded, heated or air-conditioned dressing-rooms equipped with 2 towels.

b) A hot meal for 2 persons

c) other requirements as per rider

d) 4 complimentary tickets.

11. Promoter arranges for free groundtransport from/to the next international airport, main trainstation, hotel and venue according to the needs of the artist.

12. Other details: ALL EXCEPTIONS TO THE ARTIST RIDER MUST BE APPROVED IN ADVANCE BY MANAGEMENT

13. In case of "openair" performances it has to be guaranteed that concert can take place as well under bad weather conditions or if concert needs to be cancelled because of bad weather that the agreed fee + hotel-expenses will be paid in full without any deductions!

14. The type of venue is part of this contract. Any change of venue or capacity has to be agreed upon with artist. In case artist wasn't informed by promoter about different performance conditions artist would have the right to cancel the performance. In this case the contracted financial + other conditions still need to be fulfilled by promoter!

15. Both parties are obliged to keep the agreed terms of this contract. In the event of this contract being broken, a conventional penalty of the agreed fee becomes payable.
 SHORT NOTICE CONCERT-CANCELLATIONS WITHIN 60 DAYS OR LESS BEFORE PERFORMANCE-DATE ARE ACCEPTABLE ONLY AGAINST 100% PAYMENT OF THE AGREED FEE + HOTELEXPENSES!

ACTS OF GOD CONSTITUTE EXTENUATING CIRCUMSTANCES

If reasons of „force majeure“, such as illness proven to constitute an impediment to the artist, prevent the concert from being held, both parties shall be released from their duties hereunder, notwithstanding that they may agree to hold the concert on another date.
 In the event that the organizer or the artist are prevented from holding the event for reasons of force majeure (i.e. Covid-19 related decrees), the parties are released from their contractual obligations.

Appropriate Law-court is Schwaz, Austria or any other Law-court of agent's choice.
 Contract must be countersigned and returned within 2 weeks after date of issue.
